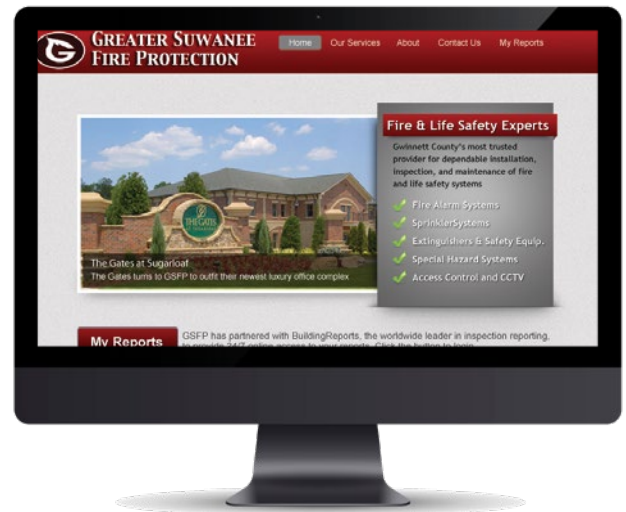

Icons are color-coded to indicate the status of each device, and can be filtered to only display specific device types on the floor plan. Floor Plans even allows for animated time-lapse recreations of the inspection for quality assurance and additional inspections verification.
